- **25-102.1-Complaints concerning events playing loud music past 11pm-** To discuss and decide what the Council can do about events that play music past 11pm -A letter to be written to NFDC Environmental Health by clerk on behalf of the Council stating the recent events that have caused noise disturbance.
 - **25-102.2** -To have an update on TENS monitoring *Monitoring occurred twice but unfortunate timing meant the music makers were on a break and could not be observed.*
 - **25-102.3** -To discuss and decide what can be done about complaints regarding recent 'Singing Sticks' event. -Council to possibly contract groups directly to ask them to consider the community around them when making noise. Cllrs to see if contact details can be found.
- 25-103 Complaints about the road crossing at Martin Drove End and the A354- To discuss and decide what the parish council can do regarding this road crossing. Clerk to contact Highways to point out the warning signs cannot be seen from a distance due to tree growth. Also to ask if solar lights can be placed over the 'No Entry' signs on the A354 to help prevent people driving up the wrong way.
- **25-104- Complaints regarding the speed of vehicles on Sillens Lane-** To discuss and decide what measures can be taken. *-Clerk to look for a sign that can be added to the current post asking for people to 'Slow Down'. Clerk may spend up to £80.*
- **25-105 Footpath 501** To receive an update regarding the locking of the gate at footpath 501 and to decide on any further action. -*Councillor Greenwood to seek out a solicitor for advice concerning the lock on the gate.*
- **25-106 Vacant Councillor Position –** To discuss and decide further action to recruit a new councillor for co-option. *-Cllr Greenwood and Cllr Richards to approach 2 candidates regarding the position.*

Clerk to check if lowest quote for £288 does include both the recreation grounds and the orchard. Clerk instructed to accept whatever company has the lowest quote for both sites.
